3. The Society / School shall not collect any capitation fee and subject the child or his or her parents or guardians to any screening procedure.
4. The School shall not deny admission to any child
 - (1) For lack of age proof.
 - (2) If such admission is sought subsequent to the extended period of 90 day for admission.
 - (3) On the ground of religion, Caste or race, place of birth or any of them
5. The School shall ensure that No child admitted shall be held back in any class or expelled from school till the completion of Elementary Education in that school.
 - (i) No child shall be subjected to physical punishment or mental harassment.
 - (ii) No requirement to pass any Board examination till the completion of Elementary Education.

 - (viii) The Teacher shall not engage himself or herself for private teaching activities.


